Policies and Procedures

(SBP-BSC) Basic Steps Checklist Design/Bid/Build Projects

In an effort to make the Basic Steps Checklist more comprehensive among the other policies, sections have been renamed for ease of maneuvering through the document. Steps have also been added that were always in policy but not noted in these Basic Steps

- Revised A.1 from Setting Up A Project to Unrestricting Funds
- Added steps in A.2 Setting up a Project
- B1 renamed to Starting a Project Professional Services
 - o 12b: Added reference to the 6-month rule

Exception <u>#1</u>: A State Controller Office (SCO) waived contract could <u>also</u> be waived f<u>rom</u>or Attorney General <u>legal</u> legal review and <u>signature</u> by State <u>Buildings/Delegate</u>. If a delegated agency has classified the risk of the amendment according to State Controller Fiscal Rule.

Exception #2: After the approved amendment establishing the GMP on a CM/GC, D/B LS or D/B GMP construction agreement, all subsequent amendments incorporating anticipated bid packages may be waived for Attorney General/Delegate legal review and signature upon request approval by the State Controller/Delegate.

(SBP-PROJ-MON-COST-MGMT)

Contingencies are established to compensate for unknowns. It is not expected, however, that the budgeted sub-category amounts are fixed and static. Contingency dollars can move from one category to another as required **provided that they are not used to increase the scope of work outside the legislative intent of the appropriated funds**. The portion of the contingency attributable to the construction budget should not be factored into the Authorization to Bid (SBP-6.10) line C nor should it be used in order to compensate for a bid overage without first consultant with the Office of the State Architect.
